

- 'Unique' organizational chart – patients at the centre
- Health authorities have operational responsibility for delivery of programs
- BCPRA forms an overarching support for those programs, and is accountable to the PHSA and MOH for outcomes



Why the Network Works

- Matrix reporting of HA renal programs to HA and BCPRA
- Protected renal care funding: \$163 million annually
- Provincial contracts (and value add \$\$ for HAs)
- Dedicated information system: by us and for us
 - PROMIS
- Selection of metrics and KPIs by and for renal community

Impact of CKD Care: Dialysis Initiation and Survival

Unique set of cohorts

- 10,111 CKD patients in BC from 2003-2007
- Basis for ongoing outcomes evaluation for clinical, CQI and research purposes.
- Over time, CKD care has made a significant impact on:
- Delay in progression (less RRT starts)
- 2. Overall patient survival





Figure 1. Kaplan-Meier Overall Patient Survival Curves by Year of CKD Initiation

Value Add Dollars from Industry Support Innovation, Improve Renal Care



From projects focused on quality improvement and process redesign, to enhanced patient and staff education, value-added funds from provincial renal contracts negotiated by the BC Provincial Renal Agency (BCPRA) and Health Shared Services BC (HSSBC) improve care for patients and quality of worklife for renal care providers across BC.

Although a portion of these funds are used at the provincial level to support cross-provincia initiatives of the BC renal network, the majority is allocated to health authority renal programs to meet diverse needs at the local level.
