## 1.0 Scope of Guideline

This guideline makes recommendations on the nursing management of complications during hemodialysis. An attempt is made to list the steps in sequential order; however, in reality, many of these steps are performed simultaneously depending on the clinical situation.

Applicability: In centre and community hemodialysis (HD) units

## 2.0 Recommendations

**Recommendation #1: Implement the recommendations on the next set of tables for the nursing management of complications during hemodialysis.**

### 2.1 Air in Bloodline

Complication	Possible Cause(s)	Signs & Symptoms	Nursing Management
Air in bloodline <sup>2,34</sup>	<ul style="list-style-type: none"><li>• Connections and caps loose within the extracorporeal circuit</li><li>• Improper priming of dialyzer and bloodlines</li><li>• Incorrect system settings</li><li>• Clamp to the medication line left open upon accessing</li><li>• Cracked catheter</li><li>• Empty air vented IV bottle (e.g., albumin)</li><li>• Defective manufactured product (e.g., small hole or puncture in the bloodline; flaw in dialysis needle/angiocath)</li><li>• Low levels of blood in arterial or venous drip chambers</li></ul>	<ul style="list-style-type: none"><li>• Visible air in lines</li><li>• Air detector alarm</li></ul> <p>If not remedied, potential to cause <a href="#">air embolism</a> and <a href="#">circuit clotting</a>.</p>	<ul style="list-style-type: none"><li>• Turn blood pump off</li><li>• Immediately clamp patient's access and machine bloodlines</li><li>• Investigate cause and magnitude of air in circuit</li><li>• Secure any loose connections and clamp vented IVs</li><li>• If air is noted after venous sensor, attach empty sterile syringe to patient's access and aspirate any air, if possible. Clamp</li><li>• Keep access patent while troubleshooting as per HA protocol</li><li>• If unable to clear or remove air from bloodline, do not return blood and use a new set up</li><li>• Follow machine-specific guidelines as to how to remove the air from the circuit</li></ul>

## 2.2 Air Embolus

Complication	Possible Cause(s)	Signs & Symptoms	Nursing Management
<p><b>Air embolus</b><sup>1,4</sup></p> <p><b>Definition:</b> An air embolism, also known as a gas embolism, is a blood vessel blockage caused by one or more bubbles of air or other gas in the circulatory system<sup>i</sup></p>	<ul style="list-style-type: none"> <li>Loose connection or leak in the extracorporeal circuit</li> <li>Open clamp during catheter care</li> <li>Accidental disconnection of vascular access</li> <li>Air entrapment during CVC insertion or removal</li> <li>Air infused during improper reinfusion</li> <li>Defective or faulty air detector on HD machine</li> <li>Faulty blood line</li> </ul>	<ul style="list-style-type: none"> <li>Patient complains of hearing the sound of a train or rushing air</li> <li>Visible air/foam in venous blood</li> <li>Chest pain, dyspnea, coughing, cyanosis</li> <li>Visual disturbances</li> <li>Churning sound on auscultation of heart</li> <li>Neurologic deficits: confusion, coma, hemiparesis</li> <li>Loss of consciousness</li> <li>Cardiac/respiratory arrest</li> </ul>	<p>Immediate management of patient:</p> <ol style="list-style-type: none"> <li>Turn off blood pump and DO NOT RETURN BLOOD</li> <li>Immediately clamp all lumens of patient's access &amp; ALL bloodlines</li> <li>Place patient in a head down, feet up position on their LEFT side.</li> <li>Disconnect bloodlines &amp; aspirate any remaining air with a 10cc syringe from both lumens beginning with the VENOUS lumen</li> <li>Check SpO2. As needed, place patient on high flow oxygen mask (100% oxygen). Monitor SpO2</li> <li>Obtain assistance. Initiate resuscitation procedures, including calling Code Blue or 911, if indicated.</li> <li>Call MD/NP</li> </ol> <p>Explore possible causes of air embolus: Refer to column 2 (Possible Cause(s)).</p>

## 2.3 Anaphylaxis

Complication	Possible Cause(s)	Signs & Symptoms	Nursing Management
<p><b>Anaphylaxis – non-dialyzer related cause</b><sup>5</sup></p> <p><b>Definitions:</b> Anaphylaxis is a potentially life-threatening allergic reaction that is rapid in onset. Anaphylaxis occurs with exposure to a trigger in a susceptible individual. Onset of symptoms usually occurs in minutes but can occur hours after exposure to a trigger. Death from anaphylaxis occurs as a result of severe respiratory complications, cardiovascular collapse, or both<sup>ii</sup></p>	<p>May be allergic or non-allergic:</p> <ul style="list-style-type: none"> <li>Allergic causes include medications, iron, latex, food, etc</li> <li>Non-allergic causes include idiopathic anaphylaxis &amp; anaphylactoid reactions (e.g., response to opiates, NSAIDs &amp; radiocontrast dyes/agents)</li> </ul>	<p><b>Skin:</b></p> <ul style="list-style-type: none"> <li>Angioedema and tingling to face and mouth</li> <li>Hives – may be delayed</li> </ul> <p><b>Anaphylaxis can occur without presence of hives</b></p> <ul style="list-style-type: none"> <li>Warm, itchy, red and blotchy</li> </ul> <p><b>Respiratory:</b></p> <ul style="list-style-type: none"> <li><b>Labored breathing</b> - Hoarse voice, throat tightness, rapid breathing, wheezing, coughing, nasal flaring, nasal and chest congestion</li> <li>Rhinitis (stuffy or runny nose, itchy watery eyes and sneezing)</li> <li>Dyspnea – difficulty filling lungs</li> </ul>	<ol style="list-style-type: none"> <li>Assess client for signs &amp; symptoms of anaphylaxis: <ul style="list-style-type: none"> <li>Circulation, airway, breathing (CAB)</li> <li>Skin, mental status and GI</li> </ul> </li> <li>Remove/stop offending agent/drug (if possible)</li> <li>Stop dialysis. Return the patient's blood to the patient. Maintain HD access until an adequate alternative is available</li> <li>Promptly perform <b>simultaneously</b> the following actions: <ul style="list-style-type: none"> <li>Administer Epinephrine intramuscular (IM) as per MD/NP order/HA protocol <ul style="list-style-type: none"> <li>Adults (14 yrs and older): 0.5 mg (of 1 mg/ML) IM mid lateral thigh</li> <li>Children (under 14 yrs): 0.01 mg/kg of 1 mg/mL to max 0.5 mg/dose IM mid lateral thigh</li> </ul> </li> <li>Call Code Blue or 911</li> <li>Reassess Circulation, Airway, Breathing (CAB)</li> <li>Administer oxygen for hypoxia if available. Goal: SpO2 above 92%</li> </ul> </li> </ol>

Complication	Possible Cause(s)	Signs & Symptoms	Nursing Management
<p><i>Anaphylactoid reactions</i> produce a clinical presentation similar to anaphylaxis but are not IgE mediated and occur through a direct nonimmune-mediated release of mediators from mast cells or direct complement activation</p> <p>If dialyzer is the suspected cause, refer to “Dialyzer reaction/membrane incompatibility”</p>		<p><b>Cardiovascular:</b></p> <ul style="list-style-type: none"> <li>• Weak and rapid pulse</li> <li>• <b>Hypotension is less common in children</b></li> <li>• <b>Hypotension alone after an exposure can represent anaphylaxis</b></li> <li>• Shock</li> </ul> <p><b>Gastrointestinal:</b></p> <ul style="list-style-type: none"> <li>• Nausea, vomiting, abdominal pain or cramping and diarrhea</li> <li>• Dysphagia (difficulty swallowing) and drooling in children</li> </ul> <p><b>Other:</b></p> <ul style="list-style-type: none"> <li>• Sudden lack of energy (lethargy), quietness or sleepiness in children</li> <li>• Headache, dizziness or light-headedness, decreased level of consciousness. Anxious or feeling of “impending doom”. Uterine cramps</li> </ul>	<ul style="list-style-type: none"> <li>• Place in recumbent position / elevate legs if possible</li> <li>• Call MD/NP</li> </ul> <ol style="list-style-type: none"> <li>5. Continuous observation: Vital Signs Q5 minutes until transfer of care</li> <li>6. Repeat Epinephrine (IM) Q5 minutes PRN x 2 doses as per MD/NP order/ HA protocol for ongoing signs and symptoms of anaphylaxis</li> <li>7. Connect IV line with attached bag of normal saline to venous needle/lumen</li> <li>8. Provide handover to Code Team or Paramedics: Time of onset and nature of symptoms <ul style="list-style-type: none"> <li>• Interventions provided including timing and amount of epinephrine</li> <li>• Response to treatment</li> </ul> </li> </ol>

## 2.4 Blood in Dialysate

Complication	Possible Cause(s)	Signs & Symptoms	Nursing Management
Blood in dialysate <sup>2,6-8</sup>	<ul style="list-style-type: none"> <li>• Fractured dialyzer membranes</li> <li>• Cracked or faulty dialyzer headers</li> <li>• Hemolysis</li> </ul> <p>May also be a false alarm which might have been caused by a faulty blood leak detector</p>	<ul style="list-style-type: none"> <li>• “Blood in dialysate” alarm (HD machine)</li> <li>• Visible blood in outflow dialysate hose</li> <li>• Positive chemstrip</li> </ul>	<ol style="list-style-type: none"> <li>1. Stop dialysis and clamp bloodlines and patient access</li> <li>2. Check vital signs</li> <li>3. Inspect the dialyzer and outflow dialysate hose for blood leak</li> <li>4. If no visible blood leak, remove dialysate hose from the connector port &amp; test dialysate outflow fluid with test strip (e.g., Chemstrip, Hemastix®)</li> <li>5. If test strip negative, restart dialysis and increase blood pump slowly. If alarm reoccurs, test again with test strip</li> <li>6. If chemstrip tests positive OR blood is visible, treat as blood leak: <ol style="list-style-type: none"> <li>a. Do not return patient’s blood</li> <li>b. Contact MD/NP re: recommencing dialysis with new dialyzer and new machine and possible bloodwork (e.g., potassium) and prophylactic antibiotics</li> <li>c. Monitor vital signs</li> <li>d. Review recent bloodwork and notify MD/NP of blood loss as patient may require complete CBC to be drawn at next HD treatment</li> <li>e. Do heat and chemical disinfection on the original machine (do not run any other patients on this machine until disinfected)</li> <li>f. Record dialyzer lot number &amp; retain dialyzer for post-investigation by the vendor</li> <li>g. Inform MD/NP, charge nurse &amp; biomed of all blood leaks</li> </ol> </li> </ol>

## 2.5 Cardiac Arrest (Intradialytic) with Resuscitation

Complication	Possible Cause(s)	Signs & Symptoms	Nursing Management
<p><b>Cardiac arrest (intradialytic) with resuscitation</b> <sup>9,10</sup></p> <p><b>Definition:</b> Sudden cardiac arrest is the sudden, unexpected loss of heart function, breathing and consciousness. Sudden cardiac arrest usually results from an electrical disturbance in your heart that disrupts its pumping action, stopping blood flow to the rest of your body <sup>iii</sup></p>	<ul style="list-style-type: none"> <li>• Electrolyte/acid-base imbalance</li> <li>• Dysrhythmias</li> <li>• Myocardial infarction</li> <li>• Hypoxemia</li> <li>• Large air embolus</li> <li>• Pulmonary embolus</li> <li>• Hemolysis</li> <li>• Exsanguination</li> <li>• Hypotension</li> <li>• Hypovolemia</li> <li>• Hypoxia</li> <li>• Acidosis</li> <li>• Hypoglycemia</li> <li>• Hypothermia</li> <li>• Hyperthermia/overheated dialysate</li> <li>• Tension pneumothorax</li> <li>• Tamponade</li> </ul>	<ul style="list-style-type: none"> <li>• Absence of apical/ carotid or femoral pulse</li> <li>• Lack of spontaneous respiratory effort</li> <li>• Unresponsive to stimuli</li> <li>• Asystole or ventricular fibrillation on cardiac monitor</li> </ul>	<p>Promptly perform <b>simultaneously</b> the following actions:</p> <ul style="list-style-type: none"> <li>• Shout for help from other staff members – do not leave the patient</li> <li>• Review MOST if available</li> <li>• Notify MD/NP.</li> <li>• Call CODE BLUE/911: <ul style="list-style-type: none"> <li>• In-centre units: Call CODE BLUE</li> <li>• Community Dialysis Units (CDUs): Call 911 or CODE BLUE as per unit policy</li> </ul> </li> <li>• Commence CPR &amp; activate the emergency resources used for cardiac arrest</li> <li>• Stop dialysis. Return blood to patient if safe to do so &amp; bolus of 0.9% NaCl PRN. Disconnect bloodlines from patient's access. Connect IV line with attached bag of NS to venous needle/lumen</li> <li>• Flush with normal saline. Cap off other needles/ lumens</li> <li>• Move dialysis machine away from area if possible.</li> <li>• Secure access until transfer of care per CODE or 911 team, then remove needles/cap CVC (once alternate access established)</li> <li>• Patient's assigned nurse to provide handover</li> <li>• Delegate nurse to record CODE events</li> <li>• Follow health authority protocol for follow-up of patient</li> </ul>

## 2.6 Chest Pain (Intradialytic)

Complication	Possible Cause(s)	Signs & Symptoms	Nursing Management
<p>Chest pain (intradialytic) <sup>2,4,11,12</sup></p>	<p>Cardiac causes:</p> <ul style="list-style-type: none"> <li>• Underlying coronary artery disease with demand ischemia from low BP, high ultrafiltration rate, anemia</li> <li>• Myocardial infarction</li> <li>• Angina</li> <li>• Arrhythmia</li> </ul> <p>Differential diagnosis:</p> <ul style="list-style-type: none"> <li>• Pulmonary embolus</li> <li>• Air embolism</li> <li>• Hemolysis</li> <li>• Pericarditis</li> <li>• Dialyzer reaction</li> <li>• Fluid overload</li> <li>• Infection</li> <li>• Disequilibrium syndrome</li> <li>• Musculoskeletal</li> <li>• GERD</li> </ul>	<p>General: pain or tightness in the chest, back, arm or jaw which may be accompanied by nausea, dyspnea and diaphoresis</p>	<p><i>Management:</i></p> <ul style="list-style-type: none"> <li>• Place machine in minimum ultrafiltration rate (UFR)</li> <li>• Decrease pump speed to 250 ml/min</li> <li>• Assess vital signs</li> <li>• Assess nature of chest pain, including location, radiation, character, severity, exacerbating or relieving factors, duration and frequency and associated symptoms (e.g., syncope)</li> <li>• If chest pain accompanied by hypotension &amp;/or hemodynamically unstable: <ul style="list-style-type: none"> <li>• Position in supine with raised legs as tolerated, or lay flat if respiratory status allows</li> <li>• Return patient's blood and administer 0.9% NaCl 250 mL.</li> <li>• Call MD/NP.</li> </ul> </li> <li>• If hypoxemic (SpO2 &lt;92% on room air), administer oxygen at 1-5L/min via nasal prongs or simple mask at 6-10L/min.</li> </ul>

Complication	Possible Cause(s)	Signs & Symptoms	Nursing Management
			<ul style="list-style-type: none"> <li>• Titrate oxygen to achieve SpO<sub>2</sub> &gt;92%</li> <li>• If blood pressure is not substantively reduced when chest pain manifests: <ul style="list-style-type: none"> <li>• If ordered, administer 1 - 2 sprays nitroglycerin (NTG) SL</li> <li>• If not resolved in 5 min and upon MD/NP order, repeat NTG SL Q5 min as necessary for a maximum of 3 doses. If still not resolved, call MD/NP and prepare patient for transfer of care/specialty consultation</li> </ul> </li> <li>• Arrange investigations as ordered by MD/NP. e.g., troponin and STAT ECG, Hgb level</li> <li>• If chest pain resolves or a non-cardiac cause established, proceed with UFR and dialysis as directed by MD/NP</li> </ul> <p><i>Prevention:</i></p> <ul style="list-style-type: none"> <li>• Assess UF goal and ultrafiltration rate, and estimated dry weight</li> <li>• Avoid high UF rates</li> </ul>

## 2.7 Clotted Extracorporeal Circuit

Complication	Possible Cause(s)	Signs & Symptoms	Nursing Management
Clotted extracorporeal circuit <sup>2,13,14</sup>	<ul style="list-style-type: none"> <li>• Inadequate heparin</li> <li>• Changes to systemic anticoagulation therapy (e.g., warfarin)</li> <li>• Inadequate blood flow/ blood pump speed during dialysis</li> <li>• Single needle dialysis</li> <li>• Kinked tubing, line clamps, infiltrated needle, etc</li> <li>• Hemoconcentration due to excess fluid loss</li> <li>• Elevated hemoglobin (high hematocrit)</li> <li>• Transfusion of PRBCs or parenteral nutrition with lipids</li> <li>• Change in dialyzer type (dialyzer new to patient)</li> <li>• Incomplete priming of dialyzer</li> <li>• Air in bloodline</li> <li>• Frequent pump stops during run</li> </ul>	<ul style="list-style-type: none"> <li>• Rising venous/ arterial pressures</li> <li>• Dropping venous pressure</li> <li>• Change to transmembrane pressure (TMP)</li> <li>• Decrease in dialysis clearance</li> <li>• Upon flushing circuit, visible streaking in dialyzer or clot/ dark red blood in the circuit</li> <li>• Transducer monitors filling rapidly with blood (older machines)</li> </ul>	<ul style="list-style-type: none"> <li>• If anticoagulant-free HD, intermittently flush circuit to visualize presence of clot(s) in chamber or dialyzer as per HA protocol.</li> <li>• Rule out causes such as kinked/occluded tubing, infiltrated needle, etc.</li> <li>• Flush circuit to determine extent of clotting as per Health Authority protocol.</li> <li>• If signs of clotted circuit are worsening, consider returning patient's blood. DO NOT <u>manually</u> (hand crank) return blood.</li> <li>• If circuit completely clotted, stop dialysis and discard the circuit. DO NOT RETURN BLOOD. Recommence HD with a new circuit as per HA protocol. Check hemoglobin next HD run or with resumption of HD.</li> <li>• Inform MD/NP to review heparin dose or follow HA protocol.</li> </ul>

## 2.8 Dialyzer Reaction / Membrane Incompatibility

Complication	Possible Cause(s)	Signs & Symptoms	Nursing Management
<p>Dialyzer reaction/membrane incompatibility <sup>1,2,8,15,16</sup></p> <p>Response may be anaphylaxis or anaphylactoid</p>	<p>Immediate/delayed reaction:</p> <ul style="list-style-type: none"> <li>Hypersensitivity to dialyzer membrane or sterilant, especially ethylene oxide (ETO)</li> <li>Contamination by bacterial peptides</li> </ul> <p>Old/expired dialyzer reaction</p> <ul style="list-style-type: none"> <li>Caused by exposure to degraded products, usually associated with cellulose-based membranes</li> </ul> <p>Risk factor: Use of ACE inhibitors in patients using AN69 dialyzer (Nephral)</p>	<p><b>Immediate (onset within 1<sup>st</sup> 10 min):</b></p> <ul style="list-style-type: none"> <li>Symptoms may be mild to severe: <ul style="list-style-type: none"> <li>Skin: Pruritus, urticaria, angioedema</li> <li>Respiratory: Cough, sneezing, wheezing, SOB, laryngeal edema</li> <li>GI: Abdominal cramps, diarrhea, vomiting</li> <li>Other: Fever, chills, “impending sense of doom,” chest pain/back pain</li> </ul> </li> <li><b>Anaphylactic shock:</b> Hypotension, rash, wheeze → cardiac arrest</li> </ul> <p><b>Delayed (onset after 1<sup>st</sup> 10 min)</b></p> <ul style="list-style-type: none"> <li>More common and less severe symptoms</li> <li>Symptoms generally <u>improve</u> with continuation of dialysis treatment. Symptoms include: <ul style="list-style-type: none"> <li>Chest pain</li> <li>Back pain</li> <li>Dyspnea</li> <li>Nausea/vomiting</li> <li>Hypotension</li> </ul> </li> </ul> <p>Note: Blood and dialyzer membrane interaction can cause significant thrombocytopenia</p> <p><b>Old/Expired Dialyzer Reaction (onset within 7 – 24 hrs post-treatment):</b></p> <ul style="list-style-type: none"> <li>Rare, especially with newer synthetic membranes.</li> <li>Variable symptoms including decreased hearing and vision, conjunctivitis, headache, confusion, corneal opacification, and cardiac arrest</li> </ul>	<p><b>Immediate (onset within 1st 10 min):</b></p> <ul style="list-style-type: none"> <li><b>STOP treatment and DO NOT return blood.</b> Keep access open</li> <li>Consider calling <b>CODE BLUE</b></li> <li>Administer the following medications as per unit protocol: <ul style="list-style-type: none"> <li>Epinephrine, if anaphylaxis</li> <li>Antihistamine (e.g., diphenhydramine)</li> <li>Steroids (e.g., hydrocortisone, methylprednisolone)</li> <li>Bronchodilators. (e.g., salbutamol nebulizer)</li> </ul> </li> </ul> <p><b>Delayed (onset after 1<sup>st</sup> 10 min):</b></p> <ul style="list-style-type: none"> <li>Check vitals frequently</li> <li>Monitor symptoms</li> <li>Consider differential diagnosis (see below)</li> <li>Consider stopping treatment if symptoms progress</li> <li>Call MD/NP. ## 2.9 Disequilibrium Syndrome

<p>Dialysis disequilibrium syndrome (DDS) <sup>2,4,17-21</sup></p> <p>Many believe DDS is related to an acute increase in brain water content due to the rapid lowering of the plasma solute level during dialysis. This causes the plasma to become hypotonic with respect to the brain cells. This results in water shifting from the plasma into the brain tissue (urea concentration in blood declines faster than in brain → water shifts from blood into brain)</p>	<p>Patient risk factors:</p> <ul style="list-style-type: none"> <li>Advanced age</li> <li>Pre-existing neurological condition</li> <li>Other conditions that could cause cerebral edema (hyponatremia, hepatic encephalopathy, hypertensive emergency, etc)</li> <li>Concomitant conditions with increased blood brain barrier permeability (sepsis, vasculitis, TTP/HUS, meningitis, encephalitic, etc)</li> <li>Very high serum urea. e.g., patients who have missed several HD runs in a row</li> </ul> <p>Treatment risk factors:</p> <ul style="list-style-type: none"> <li>Full clearance dialysis (e.g., high QB; longer dialysis duration; high dialysate flow). ## 2.10 Hemolysis

<p>Hemolysis <sup>1,4,12,14,22-24</sup></p> <p><b>Definition:</b> Rupture of erythrocytes with release of hemoglobin and potassium into the plasma. 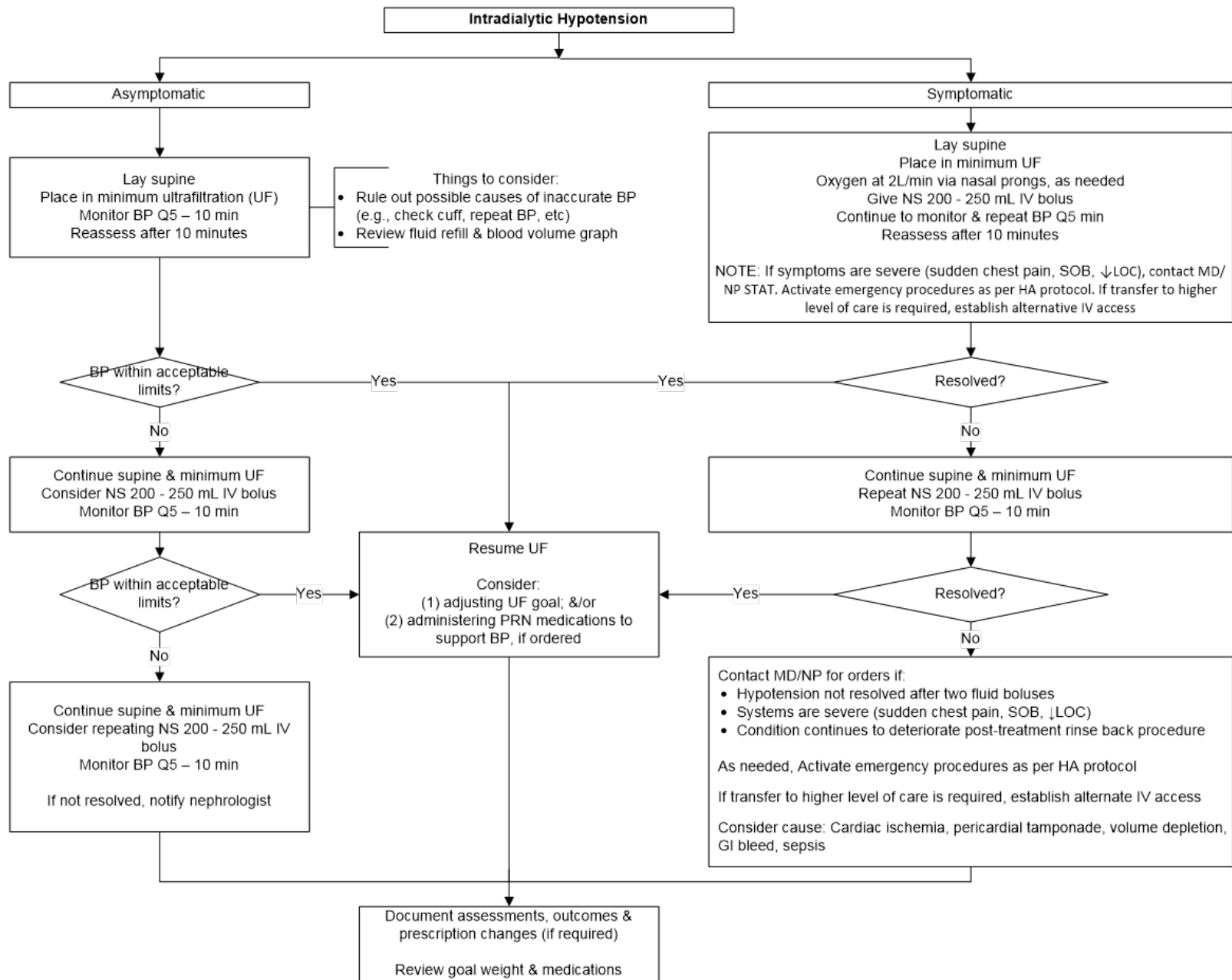

<p>Intradialytic hypotension <sup>2,25-27</sup></p> <p><b>Definition:</b> Decrease in systolic blood pressure (BP) &gt;20mmHg or a decrease in mean arterial pressure by 10 mmHg, provided that the decrease in BP is associated with clinical events and need for nursing interventions<sup>28</sup></p> <p>Hypotension may be minor or severe, asymptomatic, or symptomatic</p>	<p>Excessive or rapid decreases in blood volume with insufficient hemodynamic compensation. ## 2.12 Muscle Cramps

## 2.13 Nausea / Vomiting

## 2.14 Pyrogenic Reaction

<p>Pyrogenic reaction<sup>12,14,31-33</sup></p> <p><b>Definition:</b> A febrile phenomenon caused by infusion of contaminated solution, and commonly manifested by cold, chill and fever</p>	<p><b>Dialysis-related:</b></p> <ul style="list-style-type: none"> <li>Pyrogens or endotoxins in the dialyzer or bloodlines, HD machine, water system &amp;/or bicarbonate containers/system</li> <li>Contaminated medication administered through the dialysis circuit</li> </ul> <p><b>Patient related:</b></p> <ul style="list-style-type: none"> <li>Bacteremia (access site or non-access related)</li> <li>Break in aseptic practices (may cause bacteremia which may lead to a pyrogenic reaction)</li> </ul> <p><b>Differential diagnosis:</b> Blood transfusion reaction (oral temperature &gt;38°C; &gt;10°C higher than baseline; or presence of chills/rigors)</p>	<p><b>Most common:</b></p> <ul style="list-style-type: none"> <li>Patient feels cold soon after initiation of dialysis, accompanied by chills and fever, often within the first 45 – 75 min of treatment</li> <li>Hypotension</li> <li>Nausea and vomiting</li> </ul> <p><b>Less common:</b></p> <ul style="list-style-type: none"> <li>Headache</li> <li>Myalgia (muscle pain)</li> <li>Hemodynamically unstable</li> </ul>	<p><b>Management:</b></p> <ul style="list-style-type: none"> <li>Assess for signs and sources of infection such as: vascular access, foot ulcer, pressure ulcer, respiratory or urinary tract</li> <li>Take vital signs, including pre-dialysis temperature</li> <li>Notify MD/NP. ## 2.15 Seizure

<p>Seizure <sup>2,4</sup></p> <p>A seizure is a sudden, uncontrolled electrical disturbance in the brain. It can cause changes in your behavior, movements or feelings, and in levels of consciousness. There are many types of seizures, which range in severity. Seizure types vary by where and how they begin in the brain. Most seizures last from 30 seconds to two minutes. A seizure that lasts longer than five minutes is a medical emergency. Blood leaks out of the vein into the surrounding tissues.</p>	<p>Cannulation-related:</p> <ul style="list-style-type: none"> <li>• Fragile or new access (higher risk)</li> <li>• Accidental “back or side wall” puncture</li> <li>• Needle malposition</li> <li>• Not enough of the needle in the vessel</li> <li>• Vessel spasm</li> </ul> <p>Other reasons:</p> <ul style="list-style-type: none"> <li>• Poorly secured access</li> <li>• Patient factors</li> <li>• (refer to section on VA disconnection/needle dislodgement guideline)</li> </ul>	<ul style="list-style-type: none"> <li>• Sudden onset of pain &amp;/or discomfort in the access area</li> <li>• Feeling of warmth/ moisture &amp;/or pressure near the cannulation site</li> <li>• Swelling at cannulation site</li> <li>• Arterial or venous pressure alarms</li> </ul>	<p><i>Management:</i></p> <p>When two needles are in-situ:</p> <ol style="list-style-type: none"> <li>1.
